Entry information: Classes are open to horses registered with the AMHA for rated classes, or unregistered horses 38" and under for the Non-rated classes. The official show rules of the American Miniature Horse Association will apply except for 4H Youth Jumper and 4H Youth Showmanship (see rules below). The AMHA Rule Book can be found online at: www.amha.org

All AMHA entries in this show must be accompanied by a photocopy (front & back) of the horse registration papers and copies of Amateur/Youth cards. AMHA membership and Amateur/Youth card applications will be available at the show **for an additional charge**.

Judges Evaluation Cards will be available in the Show Office and are completed on a voluntary basis.

All Exhibitors are welcome to participate in all shows regardless of physical or mental limitations.

Gelding status must be reflected on the papers or a show letter from the office must be provided.

Parking: Truck and horse trailer parking is in the dirt lot east of the Indoor Arena at the Fairgrounds.

Stalls: Covered outdoor stalls for exhibitors arriving Friday 5/24/2024 after 2:00 PM – Sunday 5/26/2024 at the end the show. Bring your own bedding. Please contact the show manager to make arrangements. No more than two horses per stall. Exhibitors may show out of their trailer for a fee of \$10.00 per horse. (This does not include the Dry Camping Fee)

Measuring: Horses must be measured before they enter the show ring. Measurement times: Friday 5/24/2024 5:30-6:30 pm (approx. time) / Saturday 5/25/2024 & Sunday 5/26/24 7:30-8:00 AM

Out of State Horses - Horses must be accompanied by an official health certificate dated no more than 30 days from time of arrival & a NEGATIVE test for Equine Infectious Anemia (AGID/Coggins Test) within 12 months of the date of the show.

Each exhibitor will be liable for injury that may be occasioned to any person or animal or damage to any property while on the grounds by any horse owned, exhibited by, or in his/her custody or control, and shall indemnify and hold harmless the American Miniature Horse Association, the Boulder County Fairgrounds, the Rocky Mountain Miniature Horse Club and the Show Management from and against all claims, demands, cause of action, costs, charges, and expenses of every kind and nature arising out of or which may be incurred by reason of any accident, injury, or damage to person or property caused by the ownership, exhibition, custody, or control of horses exhibited. **Presentation of signed entry blanks shall be deemed acceptance of these rules, and in the event of failure to sign the entry, the first entry into the show ring as an exhibitor or first entry of an animal owned by an individual shall be deemed to be an acceptance of said rules**.

Hardship Opportunity

There will be an AMHA Director and an AMHA Judge available after the last class of the show on Friday, 5/24/2024 to hardship eligible horses into the AMHA. Horses must be 36 months of age or greater and measure 34" or under. See the current AMHA Rule Book for complete rules and guidelines. Exhibitors must contact the Show Manager prior to the show to make arrangements.

Directions:

The Boulder County Fairgrounds is located at 9595 Nelson Rd. Longmont, CO 80501. From I-25 take the HWY 119 (Exit 240) west toward Longmont for 7.8 miles. Turn right on Nelson Rd and the Fairgrounds will be on your right approximately 1/2 mile.

4H Youth Jumpers:

4H Youth Jumpers are scored mathematically on accumulated faults, and on time to complete the course in case of ties. There will be one round which will be both scored for faults and timed. Exhibitors will be placed in order of least faults to most faults, with time utilized to break any ties (i.e. scoring by faults and then by time). There will be no additional rounds.

Each exhibitor will be timed by the Steward with a stopwatch or by automatic timer. If timed by the steward, the steward must be aligned with the start/finish cones and must time all exhibitors in a class from the same position. Timing starts when the horse's nose passes the starting line and finishes when the horse's nose passes the finish line.

a) Faults:

- Knockdowns an obstacle is considered knocked down when a horse or handler, by contact, lowers the established height of the fence in any way 4 faults.
- Refusals stopping at an obstacle without knocking it down and without backing, followed by jumping from a standstill is not penalized. However, if the halt continues or if the horse backs even a single step, side steps or circle to retake the fence, a refusal is incurred:
- 1st refusal 4 Faults
- 2nd refusal 4 Faults
- 3rd refusal Disqualification
- Circling any form of circle or circles whereby the horse crosses its original track between two consecutive obstacles, stops advancing toward the next obstacle, or turn away from the next obstacle, except to retake an obstacle after a disobedience. Crossing your own path (i.e. circling between fences, NOT retaking a fence from a refusal) 3 Faults

4H Youth Showmanship:

4H Youth Showmanship Exhibitor is to show his/her horse to the presiding (call) Judge only. The half system is used when exhibiting your horse.

In consideration of the opportunity to use the Boulder County Fairgrounds, I, for myself, my heirs, personal representatives or assigns, agree to be solely responsible for and do hereby release, waive discharge and covenant not to sue Boulder County (the "Landlord"), its elected and appointed officials, and its employees, agents and representatives, for any and all claims resulting in personal injury, accidents or illnesses (including death) to myself or my animal/s or third parties or their animals which may in whole or in part be caused by my use of the Boulder County Fairgrounds, or which may result or arise in whole or in part from my use of the Boulder County Fairgrounds, whether caused by my negligence or otherwise.

Assumption of the Risk: I understand and acknowledge that the use, handling and riding of a horse, (including, activities that involve other animals such as, without limitation, team-roping) involves risk of physical injury to any individual undertaking such activities; and that a horse, and any other animals involved in such activities, irrespective of its/their training and usual past behavior and characteristics,

may act or react unpredictably at times based upon instinct, fright or unfamiliar surroundings (for example by not as a limitation, the Boulder County Fairgrounds or being around other animals) which, likewise, is an inherent risk. I hereby assert that my use of the Boulder County Fairgrounds is voluntary and that I knowingly assume all such risks.

Severability: I further expressly agree that the foregoing waiver, assumption of risk and obligation to indemnify is intended to be as broad and inclusive as is permitted by the law of the State of Colorado and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgement of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I understand and agree that this agreement will have the effect of releasing, discharging, waiving, and forever giving up my right to bring any and all lawsuits or other actions or demands against Landlord and that I may have or have had, whether past or present, or future, whether known or unknown, whether anticipated by me.
